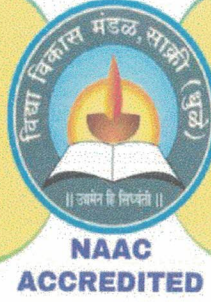

### Objectives:

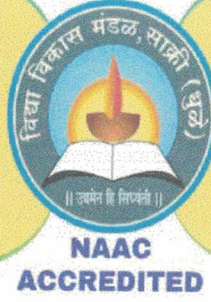
1. To maintain cordial relationships among students and student –teacher.

### Composition of Grievance Redressal Committee:

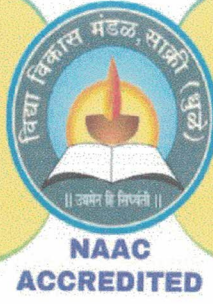
- The principal constitutes the composition of the Grievance Redressal Committee and its tenures is one year.
